(EO) 3417, EO 14156, titled "Declaring a National Energy Emergency," to improve the energy and critical minerals ("energy") identification, leasing, development, production, and transportation, and to provide a reliable, diversified, growing, and affordable supply of energy for our Tribal Nations Small Agencies and Native American Tribes by making the fullest use of existing authorities, including emergency authorities.

To our Presidential Emergency E.O. will guide you in our ask to re-assign our funding to the emergency services being that the funds were never received of it issuance since 2021, the action requesting is to sign and to apply a line of credit of the 9 billion to our allocation so we can comply to our ground breaking start up for the Mendocino County 20-years plan.

Additionally, see S.615 – A bill to enable Indian tribal governments to provide facilities necessary to carry out essential governmental functions which establishes in the Treasury the Tribal Government Lease Fund. The federal contractor will be applying his OMB Number: OMB-2700-0042-GSA-ERRC-EFFECTIVE DATE-12-16-2016, to apply federal allocated funding from the Treasury of a minimum of 9 billion dollars in helping put a development and construction of this service.

entity oversees areas that would meet the definition of multi-jurisdictional. An example of this would be a tribe whose development plan covers a reservation that contains multiple towns or villages like Mendocino Indian Reservation in having 9 districts in malty jurisdiction. Independently each town or village would be considered one jurisdiction, thus meeting the requirements of multi-jurisdictional. § 1980.1003 Applicability of Program Regulations. Except as supplemented by this subpart, the provisions of the programs identified in § 1980.1002 are incorporated into this subpart. §1980.1004

Unless the Agency publishes a notice that indicates otherwise, the Agency will reserve funds according to the procedures specified in paragraphs (a) through (c) of this section for each of the programs identified in § 1980.1002 each fiscal year. (a) Individual program basis. The Agency will reserve funds on an individual program basis.
