A. Contractor Policies Final Rule will apply this tribal consultation policy to all proposed policies that have tribal implications, to the greatest extent practicable and permitted by law. Based on a government-to-government relationship and in recognition of the uniqueness of each tribe, the primary focus for consultation activities is with individual tribes. The federal Contractor may serve, under the direction of the United States Of America, as the lead US Agency Tribal Nations Indian Self Determination and Education Assistance Contracting and Consulting officer for the implementation of this policy. Section 107 Contractor policies and procedures are from this policy Self-Determination Education Act and Energy Self Determination Act 25 CFR Part 900 Congressional Act Final Rule

B. Comment: Policy Must Address Confidentiality of Tribal Interests. One commented, citing Pueblo of Sandia v United States, 50 F.3d 856, 861-62 (10th Cir. 1995), stated that it is critical to engage in tribal consultation in a manner that exhibits sensitivity to and respect for tribal confidentiality concerns regarding cultural, religious, political, and other inter-tribal affairs.

C. Executive Order 13175 (65 FR 67249, published November 9, 2000) recognizes the right of Indian tribes to self-government and supports tribal sovereignty and self-determination. Among other things, it requires that agencies have an accountable process to ensure meaningful and timely input by tribal officials in developing policies that have tribal implications. On November 5, 2009, President Obama reaffirmed the M 10-33 government-to-government relationship between the Federal Government and Indian tribal governments in a White House memorandum that acknowledges that Indian tribes exercise inherent sovereign powers over their members and territory. The November 5, 2009, memorandum also acknowledged that the United States would continue to work with Indian tribes on a government-to-government basis to address issues concerning Indian tribal self-government, tribal trust resources, and Indian tribal treaty and other rights.

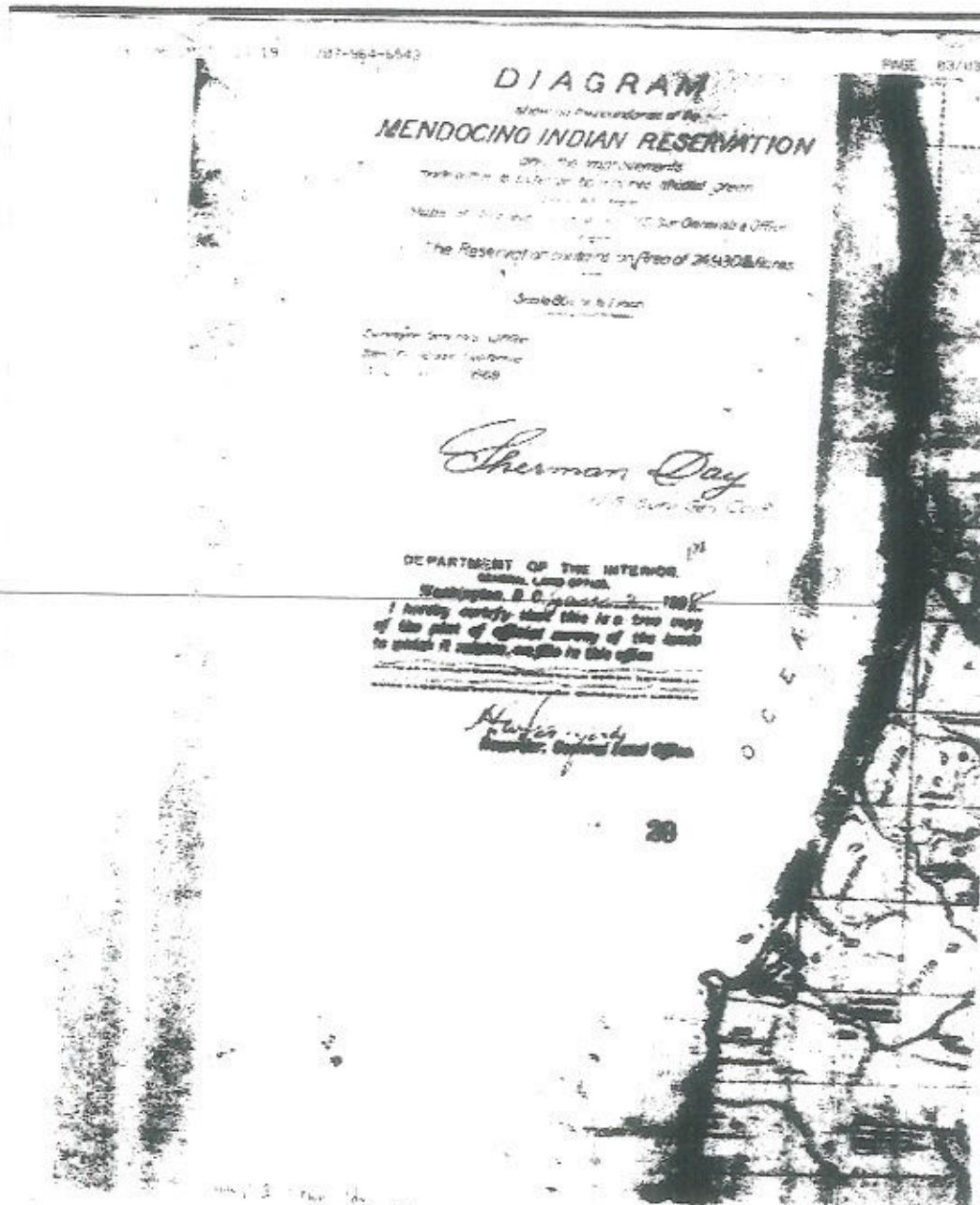

49 EXECUTIVE ORDERS RELATING TO INDIAN RESERVATIONS

MENDOCINO RESERVATION

DEPARTMENT OF THE INTERIOR,

OFFICE OF INDIAN AFFAIRS,

April 16, 1856.

Sir: Referring to the report I had the honor to submit for your consideration on the 10th of November last relative to the establishment of a military reservation for the benefit of the Indians of northern California, upon both sides of the Klamath River from its mouth the distance of 20 miles up the same; and to the remarks then made upon the subject of establishing a third similar reservation as proposed by the superintendent of Indian affairs in California, at Cape Mendocino, or at some point between that place and Russian River, &c. as opened to his office at that time more especially to that in the interior and easterly part of the State, I have now respectfully to call your attention again to the subject, and to submit for your consideration the following documents:

From these documents it appears that the section between the Novo River on the south and Bee-dah-oo or Hais Creek on the north, extending from the coast on the west to the Coast Mountains, combines advantages which are not to be found in any of the other localities examined, reference being had to the purposes for which it is required and to the habits and necessities of the Indians.

The tract intended for the reservation lies between the south bank of the Novo River, so as to include that river, and a point 1 mile north of the mouth of the Hais or Bee-dah-oo Creek, extending eastward from the coast for a quantity so as to include the valleys beyond the first range of hills to the Coast Mountains, conforming to their shape. Its geographical position is in Mendocino County, about 170 miles from San Francisco and 80 miles south of Cape Mendocino, 70 miles northwest of Clear Lake, and about 180 miles from Sacramento City.

It is proposed to embrace within the limits of the reservation 25,000 acres of land.

If upon an examination of the subject you should come to a similar conclusion, I have respectfully to request that the proposition may be laid before the President of the United States for his approval, and that the superintendent may be enabled to start out with him on his return to his post by the steamer of the 20th instant, such decision as may be made in the premises.

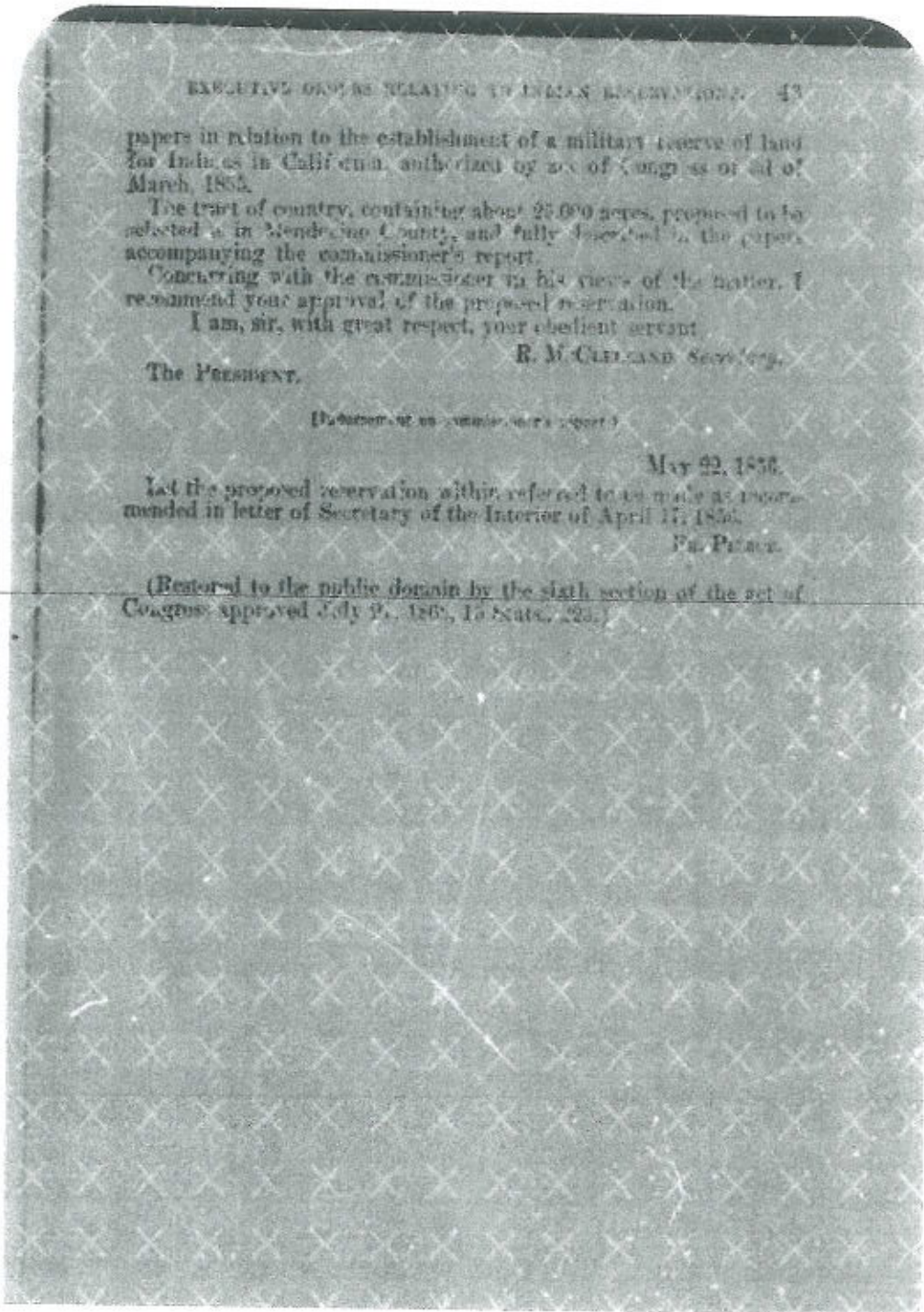

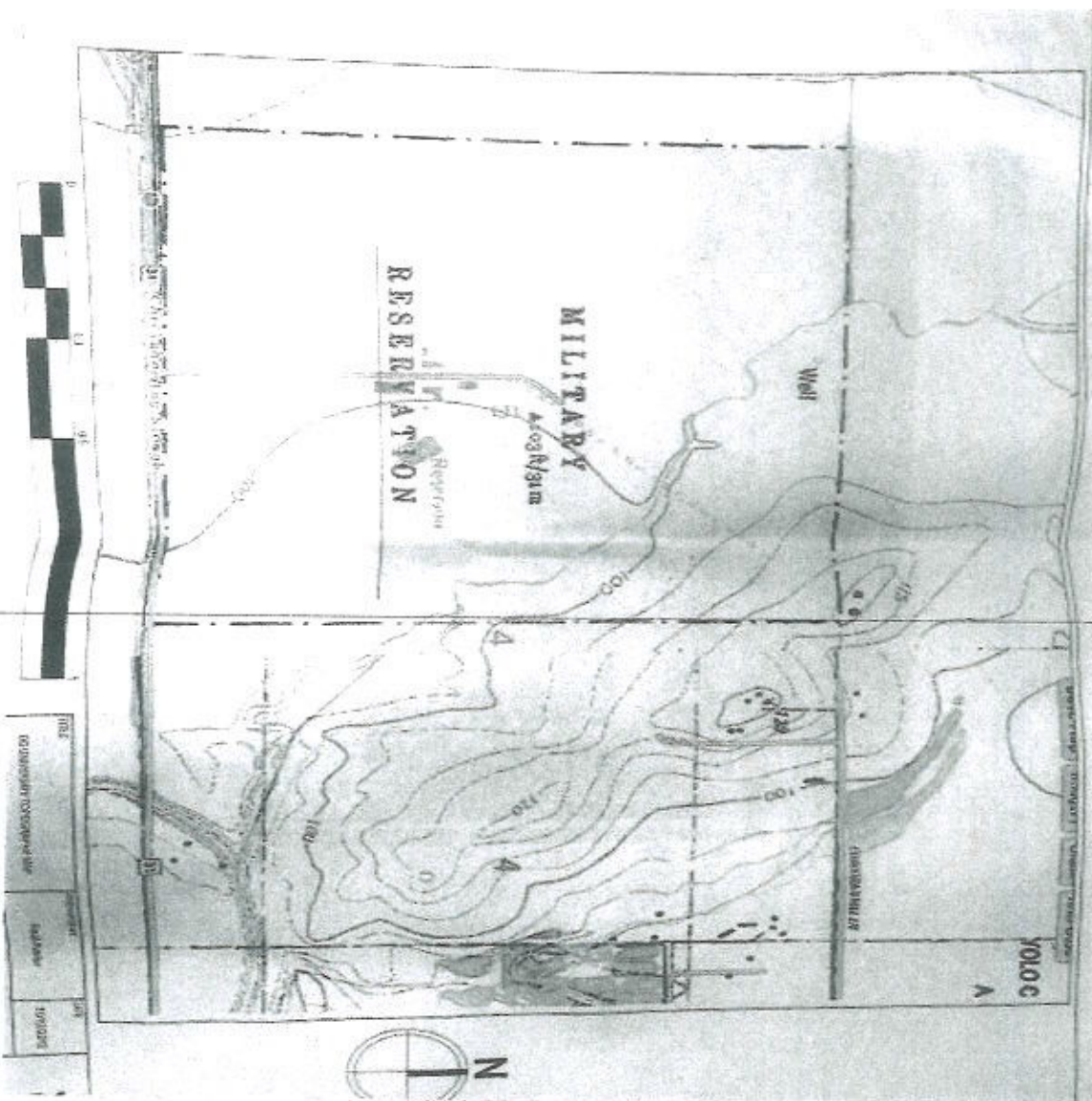
