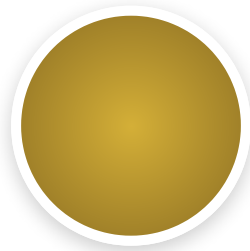
The Sovereignty Certification hereof is retroactive from birth resolving all license privilidges of use (licenses), torts from then.
